SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

If breathing is difficult, move person into fresh air. Keep at rest in a position comfortable for breathing. Immediately call a Poison Centre or doctor.

Skin Contact

Eye Contact

SECTION 5. FIRE-FIGHTING MEASURES

Extinguishing Media

Suitable Extinguishing Media

Carbon dioxide, dry chemical powder, appropriate foam, water spray or fog.

Unsuitable Extinguishing Media

Water. Do not use water jet as an extinguisher, as this will spread the fire.

Specific Hazards Arising from the Product

Flammable liquid and vapour. Can ignite at room temperature. Releases vapour that can form explosive mixture with air. May travel a considerable distance to a source of ignition and flash back to a leak or open container.

In a fire, the following hazardous materials may be generated: very toxic carbon monoxide, carbon dioxide.

Special Protective Equipment and Precautions for Fire-fighters

Fight fire from a safe distance or a protected location. Knock down vapours or gases with water fog or fine water spray. Wear fire resistant clothing.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Evacuate the area immediately. Isolate the hazard area. Keep out unnecessary and unprotected personnel. Do not touch damaged containers or spilled product unless wearing appropriate protective equipment. Eliminate all ignition sources. Use grounded, explosion-proof equipment. Use the personal protective equipment recommended in Section 8 of this safety data sheet.

Environmental Precautions

It is good practice to prevent releases into the environment. If the spill is inside a building, prevent product from entering drains, ventilation systems and confined areas. Do not allow into any sewer, on the ground or into any waterway.

Methods and Materials for Containment and Cleaning Up

Small spills or leaks: stop or reduce leak if safe to do so. Contain and soak up spill with absorbent that does not react with spilled product. Place used absorbent into suitable, covered, labelled containers for disposal. Large spills or leaks: stop or reduce leak if safe to do so. Dike spilled product to prevent runoff. Dike and recover contaminated water for appropriate disposal. Contact emergency services and manufacturer/supplier for advice.
